This is with reference to school application on the subject cited above. I am directed to convey approval of the Board for Fresh Affiliation up to Senior Secondary Level as per details given below :

Sl. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 3 (1 section each for Bal Vatika I, II & III respectively).The total number of sections from classes I to XII shall be restricted to 12. The total number of sections taken together for classes XI and XII should not be more than 1/3 of the number of section allowed including Bal Vtika. Any further increase shall require prior permission of the Board and shall be subject to compliance with the affiliation Bye laws and availability of rooms of >500 sq ft dimensions.

2	CwSN facility like ramp/lift to access upper floors is not available. However the school has shown the installation of lift is in progress. Hence the school is directed to complete the work of installation of lift and submit the compliance within 3 months on SARAS portal.
3	The entry door of CWSN toilets are very narrow for a wheelchair/walker to enter easily. The grab bars are not placed appropriately on both sides of WC of CWSN toilet. One small rod is fixed on the wall in ground floor toilets which is not at per guidelines. Thus, the school is required to construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and Board's guidelines within 03 months and submit the compliance
4	The Computer lab is understocked. As per circular No.10/2023, 01 (One) Computer System per 18 (eighteen) students with minimum of 40 computer systems must be available in computer Lab. Hence the school is directed to upgrade computer lab as per SoP issued by the Board and submit the compliance within 3 months.
5	Proper storage facility is not available in Maths lab, Composite lab and all three science labs (Physics, Chemistry & Biology). Besides, Composite lab does not have permanent workstations separately for Physics, Chemistry and Biology sections with appropriate fixture like sinks with water connection, piped gas supply on the demonstration tables. Some equipment are seen placed adjacent to side walls which is not appropriate for conduct of practical. Chemistry lab does not have fixture like piped gas supply on the demonstration table. Biology lab does not have appropriate fixture like sinks with water connection on the demonstration table. Hence the school is directed to upgrade labs as per SoP issued by the Board and submit the compliance within 3 months.
6	Library is understocked. Hence the school is directed to maintain number of students and books ratio 1:5 and a minimum of 1500 books, upgrade the library as per Board's SoP and submit the compliance within 3 months.
7	The school shall conduct training of its teachers with CoE Ajmer within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.

5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted within the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
